

SAF-T is a standard file format used to submit accounting information to the tax authorities.

1. To export a SAF-T file from Standard ERP, go to **Nominal Ledger module >> Routines >> Exports >> SAF-T**.
2. The tax authorities require a number of settings to be in place for SAF-T. Most of these are default settings in Standard ERP, but some are specific to SAF-T requirements.
In the **System module >> Settings >> Company Info >> "Email" tab >> the "Immediate Manager"** field must contain the manager's name.
3. All country codes in both the **System module >> Settings >> Company Info >> "Country" field**, and, **Sales Ledger module >> Registers >> Contacts >> "Delivery" tab >> "Country" field** must follow ISO 3166-1 alpha-2 standard which is two letters, e.g. "NO" for Norway.

5. Other settings that must be filled in:
 - **System module >> Settings >> Company Info >> "Reg" tab >> "VAT Reg. No."** field
 - **System module >> Settings >> Company Info >> "Company Name"** field
 - **System module >> Settings >> Company Info >> "Address 1" field** must contain the street name and number
 - **System module >> Settings >> Company Info >> "Address 2" field** must contain the postal code and city
 - **System module >> Settings >> Company Info >> "Reg" tab >> "Home Community"** field
 - **System module >> Settings >> Company Info >> "Telephone"** field
 - **System module >> Settings >> Company Info >> "Email" tab >> "Email"** field
 - **System module >> Settings >> Company Info >> "Reg" tab >> the "Bank Code" field** must contain the correct bank and IBAN
 - **System module >> Settings >> Company Info >> "Reg" tab >> the "Bank Code" field** must contain the correct bank and SWIFT code

- **Sales Ledger module >> Registers >> Contacts (applies to all contacts in use) >> "Company" tab** must contain the VAT number
- **Sales Ledger module >> Registers >> Contacts (applies to all contacts in use) >> "Name"** field
- **Sales Ledger module >> Registers >> Contacts (applies to all contacts in use) >> "Address 1" field** must contain the street name and number
- **Sales Ledger module >> Registers >> Contacts (applies to all contacts in use) >> "Address 2" field** must contain the postal code and city
- **Sales Ledger module >> Registers >> Contacts (applies to all contacts in use) >> "Email"** field
- **Sales Ledger module >> Registers >> Contacts (applies to all contacts in use) >> "Telephone"** field
